Rules and Regulations of the mass event organised by the University of Lodz and the Medical University of Lodz on the premises of the Student Housing Estate "LUMBOWO" at Strajku Studentów Łódzkich 1981 r. in Łódź

Chapter 1. GENERAL PROVISIONS

§1

The present Rules and Regulations of the mass event, hereinafter referred to as the Rules and Regulations, have been introduced for the performance of generally applicable provisions on the safety of mass events.

§2

- 1. The Rules and Regulations apply to the mass event JUWENALIA 2024 organised by the University of Lodz and the Medical University of Lodz, taking place on the premises of the Students Housing Estate at Strajku Łódzkich Studentów 1981 in Łódź.
- 2. In the following Rules and Regulations:
 - 1) the University of Lodz and the Medical University of Lodz are jointly referred to as the "organiser of the event",
 - 2) the event organised by the University of Lodz and the Medical University of Lodz is a "mass event",
 - 3) the designated area at Strajku Łódzkich Studentów 1981 in Łódź is referred to as the "event site".
- 3. A separate set of Rules and Regulations constitutes the Site Rules and Regulations issued by the University of Lodz and the Medical University of Lodz, which are the administrators of the property.
- 4. Persons participating in a mass event shall be subject to the regulations specified in these Rules and Regulations, the Site Rules and Regulations, as well as generally applicable provisions of law, in particular the regulations concerning security at mass events.
- 5. Entering the event site where the mass event takes place shall automatically imply acceptance of the present Rules and Regulations and the Site Rules and Regulations. Any person violating the provisions indicated in section 4 may be removed from the site by security.

The organiser of the event reserves the exclusive right to determine the rules of entry to the mass event, where the entry shall be considered as entry to the designated area of the estate.

§ 4

- 1. Only persons of legal age will be allowed to enter the event site, after presenting an identity document at the request of the organiser's information and order service.
- 2. It is prohibited to bring animals to the event site. The only exception is a guide dog.

§ 5

- 1. Entry to the event site will not be permitted to:
 - 1) persons against whom a decision prohibiting entry to a mass event has been issued,
 - 2) persons against whom a decision has been issued obliging them to refrain from staying at mass events,
 - 3) persons in relation to whom a foreign entry prohibition has been issued (pursuant to Art. 22, section 1 of the Law on mass events).
- 2. Persons who are clearly under the influence of alcohol, drugs or similar substances as well as persons behaving in a manner posing a risk of danger to other participants of the event, whose behaviour poses a threat of disruption of the course of the event, order and safety or damage to property will not be admitted to the event's venue.

§ 6

- It is prohibited to bring to the mass event and have in one's possession: weapons or other dangerous objects, explosives, pyrotechnic products, fire hazardous materials, alcoholic beverages, drugs or psychotropic substances as well as gas spraying containers, corrosive or dyeing substances, bottles and glass containers, large volume objects (such as ladders, stools, chairs, chests, suitcases, etc.), flag and banner holders, mechanically and pneumatically driven instruments.
- 2. Persons in possession of items referred to in section 1 will not be allowed to the event site.
- 3. Order and information services are entitled to inspect the contents of luggage and clothing of persons suspected of possession of items referred to in paragraph 1. Persons who do not submit to this obligation will not be allowed to enter the event site.

§ 7

Participants are obliged to occupy the area designated by the event organiser, unless the organiser decides otherwise.

Chapter 3. RULES OF CONDUCT AT THE EVENT

§ 8

Persons participating in the mass event are obliged to comply with the orders of security and information services, the police, fire department and the instructions of the event host.

Participants of the mass event are not allowed to enter places and rooms not designated for the public such as: mixer, cable tunnel, stage, backstage, performers' rooms, technical catering facilities, internal and staff areas.

§ 10

During the event the following activities are prohibited:

- 1) throwing objects that may pose a threat to life, health or safety of persons in the stadium area,
- 2) climbing buildings, roofs, fences, masts and other structures not intended for public use,
- 3) incitement to commit a criminal offence or praising such behaviours,
- 4) provoking other participants of the event to behaviours endangering the safety of the participants,
- 5) using vulgar language and insulting others, in particular the organisers and performers,
- 6) intruding and staying in a place not intended for participants,
- 7) preventing or obstructing the use of facilities intended for public use, blocking entry and exit routes and evacuation routes,
- 8) making facial recognition impossible or significantly more difficult,
- 9) lighting fires or using pyrotechnics,
- 10) damaging any elements of the site's infrastructure, including placing inscriptions and drawings on them as well as putting up stickers or posters,
- 11) displaying flags and banners with racist, offensive or provocative content on the site, including its fences,
- 12) taking care of physiological needs outside the toilets,
- 13) selling merchandise, handing out printed materials and conducting cash collections without the permission of the event organiser,
- 14) littering the premises.

§ 11

Participants of the event are obliged to immediately inform the representatives of the security or information services about any accidents or damages.

Chapter 4. POWERS AND DUTIES OF THE AUTHORITIES

§ 12

- 1. Members of the security and information services act for public safety and order at the event site, and are obliged to wear a badge in a visible place.
- 2. Members of the security and information services have the right to identify persons in order to establish their identity.
- 3. Members of the security and information services have the right to summon or instruct the participants of the event. Failure to comply with the summons and instructions may result in the removal of the person from the mass event site.
- 4. Members of the security and information services shall be entitled to check and ascertain the officers' authorisation to be present on the event site.
- Members of the security and information services are obliged to:
 1) supervise the safe entry and exit of participants,

- 2) not allowing participants of the event to enter areas not intended for the public,
- 3) responding promptly to incidents and hazards and taking necessary actions,
- 4) observe all areas of potential danger and prevent excessive crowding,
- 5) see that the provisions of the Site Regulations and these Rules and Regulations are adhered to,
- 6) respond to complaints made by participants of the mass event and to information about accidents or damage that have occurred.

§ 13

- 1. The security services are obliged to refuse entry to or remove from the mass event site:
 - 1) persons in possession of the items specified in § 6, section 1 of these Rules and Regulations,
 - 2) persons referred to in § 5 of these Rules and Regulations,
 - 3) persons who do not have an identity document or who refuse to present it,
 - 4) persons who violate prohibitions specified in § 10.
- 2. Members of the security services are entitled to apprehend, in order to immediately hand over to the Police, persons posing a direct threat to goods entrusted to security, other participants of the event and persons committing prohibited acts. In order to enforce behaviour required by law in accordance with the order issued by the entitled person or to repel direct, unlawful threat to life, health or freedom of the entitled person or any other person, security services may use means of direct coercion in the form of physical force, transport and defence techniques, handcuffs, hand-held substance throwers.

§ 14

Members of the information services are obliged to:

- 1. The information services are obliged to refuse entry to or remove from the mass event site:
 - 1) persons in possession of the items specified in § 6, section 1 of these Rules and Regulations,
 - 2) persons referred to in § 5 of these Rules and Regulations,
 - 3) persons who do not have an identity document or who refuse to present it,
 - 4) persons who violate prohibitions specified in § 10.
- 2. Inform people inside the stadium of the facilities, safety requirements and rules of conduct set by the event organiser, the police or fire and rescue services
- 3. Provide information on the location of medical assistance, catering and sanitary facilities.

§ 15

If the efforts of the security or information services to enforce behaviour that complies with the provisions of the Site Rules and Regulations or these Rules and Regulations are ineffective, the organiser of the event, or their designated security officer, shall request appropriate assistance from the police.

§ 16

- 1. The participant of a mass event in possession of items referred to in § 6(1) shall be removed from the site by the information and security services during the event.
- 2. While leaving the event site, the objects referred to in § 6(1) may be collected by the information and security services. They will be returned after the person removed from the mass event has left the site, unless their possession is prohibited under generally applicable laws.

§ 17

The event organiser has the right to record the event, in particular the behaviour of persons, by means of sound and image recording equipment. The materials collected during the recording of the event which do not contain evidence allowing the initiation of criminal proceedings, proceedings in misdemeanour cases or evidence significant for such proceedings shall be stored by the organiser of the event after the end of the given event for a period of at least 30 days, and then they shall be deleted by the commission.

Chapter 6. LEGAL RESPONSIBILITY OF EVENT PARTICIPANTS

§ 18

- 1. Any participant of the mass event who violates these Rules and Regulations and the applicable legal order will be held liable on the basis of generally applicable laws.
- 2. The organiser of the event will issue a ban on entry to the event to persons who repeatedly violate these Rules and Regulations.
- Participants of the mass event shall be liable for damage caused to persons or property. The present Rules and Regulations shall be posted on the website of the event organiser and put at the entrances to the mass event site.

ORGANISER
